Dear Sir/Madam.

With a view to provide opportunity for continuance of research contributions by talented Science and Technology teachers in Universities who are nearing superannuation or have superannuated and continue to actively associate with guiding Ph.D candidates and have not completed 68 years of age in State Universities/Central Universities, the UGC has evolved the "UGC - BSR Faculty Fellowship Scheme" with the following Objectives:

- (i) To facilitate talented teachers in Science and Technology at the verge of superannuation and to continue their productive research for an additional period of THREE YEARS after superannuation.
- (ii) Tb play a role of Research Mentorship for young researchers and Ph.D students.

I am, by direction, to inform you that you have been selected after due evaluation process by the MHRD/UGC-Empowered Committee for the award of UGC-BSR FACULTY FELLOWSHIP. This Award carries the following:

- (i) The UGC-BFF Award will carry a fellowship amount of Rs. 46,500/- per month (consolidated) for a maximum duration of THREE YEARS, which would be exclusive of the pension and other retirement benefits to the teacher from the parent university.
- (ii) A Consumable/Contingency/ Travel grant of Rs. 3.0 lakhs per annum.

This award is subjected to the following conditions:

(a) The Awardee shall not hold any administrative responsibility during the tenure of the fellowship which would be from the date of superannuation.

- (b) The department/School/University shall have to provide an undertaking that the Awardee would be provided as under--
 - (i) The required laboratory infrastructure and administrative assistance for undertaking the fellowship work.
 - (ii) Permission to take a minimum of TWO stipendiary candidates for Ph D under the UGC-BSR Faculty Fellowship Awardee.
 - The awardee shall execute an undertaking to UGC in the enclosed format duly endorsed by the Head of the Department and Registrar/Vice Chancellor of the university, white joining the fellowship. He/she would be abide by the norms and guidelines of UGC, pertaining to the UGC-BFF Award from time to time and to send the bi-annual progress report and the UC/annual audited statement of Accounts.

You are requested to acknowledge the receipt of this letter of Award and willingness to accept the same within fifteen days, through proper channel.

- 4. The Grant is subject to the adjustment on the basis of Utilization Certificate in the prescribed proforma submitted by the University/ Institution.
- 5. The University/Institution shall maintain proper accounts of the expenditure out of the Grants which shall be utilized only on approved items of expenditure.

The University/Institution may follow the General Financial Rules, 2005 and take urgent necessary action to amend their manuals of financial procedures to bring them in conformity with GFRs, 2005 and those don't have their own approved manuals on financial procedures may adopt the provisions of GFRs, 2005 and instructions/guideline there under from time to time.



Welcome to the community of the Associate Members of the Abdus Salam International Centre for Theoretical Physics! I am happy to inform you that you have been appointed a

Senior Associate of the Centre from 1 January 2012 until 31 December 2017.

This award is, however, subject to the availability of funds each year. Please refer to the Annex to this letter for details.

Senior Associates have at their disposal the sum of Euro 8,000 (this amount may be modestly increased in the near future) to be spent over the above six-year period. These funds can be made available in the form of a daily allowance (which we expect to substantially increase over the next three years) and/or travel expenses in connection with Associate visits. We hope, however, that your travel expenses can be covered by other sources. You may, of course, visit at a time of your own choosing, though it may be more useful to plan these visits when scientific activities in your area of research are being held. The duration of each visit should not exceed 70 days.

In the spirit of making your Associateship appointment as profitable and flexible as possible, you may request your Associateship funds to cover external visits to Institutes which have a Partnership Agreement with the Centre. Requests for these visits must be made through the Associate Scheme Office. The concurrence of both the Associate Scheme Office and the Partner Institute is essential before such visits can be made. Rules governing external visits to Partner Institutes are also given in the Annex.

The enclosed Form A should be sent to the Associate Scheme Office by 30 November of the year preceding the proposed visit. The same procedure applies to requests for visits to Partner Institutes. All requests will be considered taking into account the financial availability at the time.


