

The Digital India Programme is a flagship programme of the Government of India with a vision to transform India into a digitally empowered society and knowledge economy. Survey of India (SoI), the National Mapping Agency, under the Department of Science & Technology which bears the responsibility for producing, maintaining, and disseminating the National Topographic Data Base (NTDB) of the Country, has also taken initiative in this direction.

2. SoI has developed a mobile application named "SAHYOG" for its users viz., Government (Centre / State / PSUs) Department, Organizations, Institutions, Govt. employees, Academic Institutions, students and Citizen of India to voluntarily support and contribute in preparing, updating and enriching the NTDB. Point of Interest (PoI) data collected using the "SAHYOG" application will be stored in the server-managed and controlled by SoI in their premises and will be used for enriching content on the public portal, for creating various applications for everyone's usage and would facilitate the building of our National data set with "SAHYOG" of people of India.

3. Further, the Department of Science & Technology (DST) has recently approved Road Map for Generation of High-Resolution National Topographic Data Base (NTDB) for the entire Country. In this attribute, collection is one of the important components where the PoI data layer will be used as a secondary source of information. This SAHYOG App can also be used by some of the Departments to collect information of their own interest which can be shared back with them. To achieve the above SoI will provide API Keys to register their employees on this app.

4. To seek active support from the State Government in the endeavour to serve the people & country, may I request you to encourage the employees of the State Government to download the SAHYOG App available on the play store for collecting PoI. Presently, it is available on the android platform and the iOS version is under development phase. Government Departments/Agencies may contact SoI Nodal Officer as under:-
