Ordinance No. 163

DIPLOMA IN RURAL CRAFT AND INDUSTRIES

- The duration of Course OF Diploma in Rural Craft and Industries shall be of one academic year. It shall be run by University Teaching Department or School of Studies of the University.
- 2. A candidate who after passing Higher Secondary (10+ 2) examination of Chhattisgarh Board of Secondary Education or any other examination recognized by the Chhattisgarh Board of Secondary Education as equivalent thereto has attended a regular course of study in the university teaching department or school of studies of the University for one academic year shall be eligible for appearing at the examination of Diploma in Rural Craft and Industries.
- No. of seats and procedure of admission shall be decided by the university.
 Reservation of seats shall be as per provisions prescribed by Government of Chhattisgarh.
- 4. The course structure along with the scheme of the examination shall be prescribed by the Board of Studies in Rural Technology.
- 5. Minimum passing marks for each paper shall be 33% and 40% in aggregate to pass the examination.

6. Successful candidates shall be awarded divisions as follows:

First Division - 60% or more marks

Second Division - 48% or more but less than 60% marks

Third Division - 40% or more but less than 48% marks.

7. An examinee who fails in any of theory paper (s) or in project report or in practical examination may appear in that paper (s) /project report/practical in forthcoming two annual examinations on payment of fee prescribed by the University as an exstudent without being required to attend further classes of regular study.

Provided that a candidate who has passed in project report and practical examination shall not be required to submit project report or appear in practical examination again while appearing as an ex-student. The marks obtained in first examination shall be carried forward.

- 8. There shall be no provision to study this Diploma course as non-collegiate candidate.
- There shall be revaluation only in theory papers.
- 10. Other provisions regarding admission, attendance examination, etc. not covered in this ordinance shall be governed by the general ordinances of the university.
