Ravishankar Shukla University (PRSU), Raipur, is pleased to announce that applications are invited from faculty members of PRSU below the age of 45 years for **Seed Money Grants** to support **Minor Research Projects**. This initiative aims to encourage innovative research and foster academic excellence within the university.

#### **Eligibility Criteria:**

- Open to faculty members of the PRSU only.
- Applicants must be under 45 years of age.

#### **Important Details:**

- The grant is intended for minor research projects across various disciplines.
- Proposals should focus on impactful and innovative research ideas.
- The funding provided will be based on the nature and scope of the proposed research.

#### **Application Process:**

Interested faculty members are requested to submit their applications in the prescribed format in triplicate including the following:

- 1. A detailed research proposal.
- 2. Item-wise financial estimates should be mentioned clearly in the projects submitted, showing rates, quantity, and total for each item. There shall not be any salary/ honorarium component in the project.
- 3. A brief CV highlighting relevant academic and research achievements.
- 4. A completed application form.

**Deadline for Submission:** [Within 30 days from the date of notification]

Applications should be sent to the Registrar, Pt. Ravishankar Shukla University, Raipur-492010, duly forwarded by the Head of the concerned department.

Tenure of the Funding: 02 years from the date of sanction of funds.

#### **Funding Amount:**

- For Science and other laboratory-related Projects: The maximum amount of the grant is limited to Rs. 4.00 lakh per faculty over 02 years.
- For Social Science, Arts & Humanities, Management, Education, and other non-laboratory related projects: The maximum amount of grant is limited to Rs. 2.50 lakh per faculty over 02 years.
