

#### **About the Event**

On May 28, 2025, an insightful session was delivered by Mr. Rajib Das, Co-Founder of Greenfinity Powertech, on "How to Plan for Start-ups and Legal & Ethical Steps." The talk was particularly focused on integrating sustainable practices and aligning entrepreneurial efforts with the United Nations Sustainable Development Goals (SDGs).

Mr. Das emphasized that modern start-ups must go beyond profitability and embed sustainability into their core vision. He pointed out that goals such as Affordable and Clean Energy (SDG 7), Decent Work and Economic Growth (SDG 8), and Industry, Innovation and Infrastructure (SDG 9) are directly linked to entrepreneurial innovation. Drawing from his own experience in the green energy sector, he highlighted how start-ups can create value by offering renewable energy solutions that reduce carbon emissions, enhance energy efficiency, and contribute to climate action (SDG 13).

He guided participants on start-up planning, beginning with idea validation, business model design, and scalability. He stressed that young entrepreneurs must focus on innovations that solve environmental challenges—such as solar, wind, and energy storage solutions—while ensuring affordability and accessibility. He further explained the significance of green entrepreneurship in addressing energy gaps in rural and underserved areas, thereby advancing social equity along with environmental responsibility.

On the legal and ethical front, Mr. Das discussed the importance of registering businesses, protecting intellectual property, and complying with environmental regulations. He underlined that ethical business conduct—such as fair labor practices, transparency, and eco-friendly operations—is not only a responsibility but also a pathway to global recognition and sustainable growth.
