

- 2. The first instalment will be released after receiving the Grant-in-aid-Bill (GIB) in the enclosed proforma duly signed by the competent authority of the affiliating institution (affixed with revenue stamp).
- 3. The second instalment will be released on receipt of a satisfactory Six Monthly Progress report along with Statement of Expenditure in the enclosed proforma. The progress reports are to be duly signed by the Supervisor and the Statement of Expenditure is to be issued by the Affiliating Institution. These documents are to be duly signed and stamped/forwarded by the competent authority of the Affiliating Institution.
- 4. Extension into the second year will be communicated on receipt of the satisfactory progress report of the first year research work. In case the progress report is delayed, the Candidate is required to mention the reasons for the delay.
- 5. The Affiliating Institution shall provide to the fellow office accommodation including furniture library and research facilities and messengerial services. For this, the ICSSR shall pay overhead charges @ 7.5% of the total expenditure incurred on the fellowship, to the public funded Affiliating Institution, after the expiry of the fellowship on submitting the audited statement of accounts including utilization certificate in Form 12A by them.
- 6. The contingency grant may be utilized for books, stationery, computer related costs, and the field work expenses connected with the research work.
- 7. All the fellowships are subject to income tax deductions, which shall be made by the affiliating institution.
- 8. The accounts and utilization certificate will be signed by the Finance Officer/Registrar/ Principal/Director in case the accounts of the Institution are audited by the CAG/AG. Otherwise, they need to be signed both by the competent authority of the affiliating institution along with a chartered accountant

With reference to your application dated 15-Nov-19 this is to inform you that you have been selected for the above award of the value Rs 10000/- (Rs Ten Thousand) per month. In addition an annual contingent grant of Rs. 4000/- (Rs. Four thousand only) will be provided for approved contingent expenditure.

- The duration of the award shall be for a period of the two years, subject to satisfactory progress of research work. The Kulpati may extend the duration of the award by one year on the recommendation of the supervisor provided that the application for extension is submitted to the university at least 30 days before expiry of original tenure of fellowship. - B. No permission shall be given to join any other course leading to degree or appear at any competitive examination during the tenure of scholarship provided that the Kulpati may, on the recommendation of the guide, permit the fellow/scholar to join a language diploma course and appear in an examination therefore.
- C. It is mandatory to furnish half yearly reports of the work done by you in June and December each year and after complication of research work, to submit a

comprehensive report of the research work, or a copy of thesis along with an abstract of the thesis to the University.

- D. If research work is abondoned without completing the work for which the scholarship is sanctioned will be liable to be returned the whole amount of scholarship paid by the University.
- E. There is an entitlement for leave for thirty days in a year in addition to the general holidays, which will not include summer/winter and Pooja vacation with the approval of the supervisor and the University. In special case temporary permission may be given to leave without scholarship for a period of not exceeding three month during the tenure of the scholarship.

While considering the fellowship award, scanned copy of the original documents related to the eligibility criteria and caste/category/others shall be submitted for further necessary action.

Duration of the fellowship is initially for a period of two (2) years from the date of joining. Fellowship may be extended maximum up to five (5) years depending on the satisfactory progress of the fellow and the completion of the Ph.D. programme.
- 4. Emoluments under Fellowship: Fellow will be designated as "DBT-JRF" with consolidated fellowship of Rs. 31,000/- per month and a contingency grant of Rs. 30,000/- per year. If the fellow has not availed institutional hostel/ residential facility, fellow will be entitled for House Rent Allowance (HRA) as per DST guidelines applicable to research fellowships.
- Release of Fellowship: Fellowship, contingency and HRA (if applicable) will be released to the host university/institution apon timely submission of requisite documents.
- Compliance with Guidelines: Mere issuance of this award letter and activation of the fellowship does not guarantee the emoluments under the fellowship and this award will be subject to compliance to the DBT-JRF Programme Guidelines as applicable from time to time.
