- The equipment purchased for the project will become the property of the relevant Department of PRSU. Upon completion of the project, it will be transferred to the Department where the project was carried out.
- All expenditures related to the Seed Money shall be maintained in a separate register & file by the Principal Investigator.
- The PI will submit a Utilization Certificate and a Statement of Expenditure (two copies) for each year to the Office of the Registrar, PRSU, duly forwarded by the Head of the Department.
- After completion of the project, the investigator shall submit the three copies of the final Utilization Certificate and the Statement of Expenditure along with the final project report to the University. The Finance Officer of the University shall audit the accounts.
- The decision of the Vice-Chancellor shall be final and binding in all respects.
- Project evaluation and progress reports, as per the guidelines provided, are to be submitted to R& D Cell.
