विश्वविद्यालय कार्यपरिषद् की बैठक दिनांक 21.08.2024 के अध्यक्ष के अनुमति से निर्णय क्रमांक 7 एवं छत्तीसगढ़ शासन, उच्च शिक्षा विभाग, मंत्रालय, महानदी भवन, नवा रायपुर अटल नगर, रायपुर से प्राप्त पत्र क्रमांक एफ 3–2/2025/38–2 दिनांक 04 जुलाई, 2025 के अनुक्रम में संशोधित अध्यादेश क्रमांक–4 Qualifications & the condition of the appointments of the Teachers in University Teaching Departments and School of Studies (अधिसूचना क्र. 2134/अका./2021 दिनांक 03.07.2021) में संशोधन को माननीय कुलाधिपति महोदय द्वारा अंगीकृत किए जाने का निर्णय लिया गया है, जो निम्नांकित है–

Ordinance No. – 04

(Revised)

(The revision is consequent upon UGC Regulation (2nd Amendment), 2023 and the para 3.3.0 of this Ordinance)

(E.C. under 21-08-2024)

Minimum qualifications and conditions for the post of Professors, Associate Professors and Assistant Professors in University for appointment of persons through Open Advertisement and promotion of working teachers through Career Advancement Scheme (CAS)

1.1.0 RECRUITMENT AND QUALIFICATIONS

- 1.1.1 The direct recruitment to the posts of Assistant Professors, Associate Professors and Professors in the University shall be on the basis of merit through all India advertisement and selections by the duly constituted Selection Committee as specified in Section 49 (2) of Chhattisgarh University Adhiniyam, 1973.
- 1.1.2 The minimum qualifications required for the post of Assistant Professor, Associate Professor, Professor, Senior Professor, Assistant Librarian, Deputy Librarian, Librarian, Assistant Director of Physical Education and Sports, Deputy Director of Physical Education and Sports and Director of Physical Education and Sports, shall be as specified by the UGC
- **1.1.3** The National Eligibility Test (NET) or an accredited test (State Level Eligibility Test SLET/SET) shall remain the minimum eligibility for appointment of Assistant Professor and equivalent positions.

Provided that candidates who have been awarded a Ph.D.Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulation, 2009, or the University Grants Commission (Minimum Standards and Procedure for Award of M. Phil./Ph.D. Degree) Regulation,2016, and their subsequent amendments from time to time, as the case may be, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or any equivalent position in University.

Provided further that the award of degree to candidates registered for the M. Phil./Ph.D. program prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances /Bye-laws/Regulations of the Institutions awarding the degree. All such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:

a) The Ph.D. degree of the candidate has been awarded in regular mode only;

- **b)** The Ph.D. thesis has been awarded by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- **d)** The candidate has published two research papers from his/her Ph.D. work out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers, based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dea(Academic Affairs) of the concerned University.

- **1.1.4** The clearing of NET/SLET/SET shall not be required for candidates in such disciplines for which NET/SLET/SET has not been conducted.
- **1.1.5** A minimum of 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed) at the Master's level shall be the essential qualification for direct recruitment of teachers and other equivalent cadres at any level.
- 1.1.6 A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC) (Non-creamy Layer)/Differently- abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf- blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
- **1.1.7** A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to19 September, 1991.
- **1.1.8** A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.
- **1.1.9** The Ph.D. Degree shall be a mandatory qualification for appointment and promotion to the post of Professor.
- **1.1.10** The Ph.D. Degree shall be a mandatory qualification for appointment and promotion to the post of Associate Professor.
- 1.1.11^{*} Deleted
- **1.1.12** the time taken by candidates to acquire M. Phil. and/or Ph.D. Degree shall not be considered as teaching/research experience to be claimed for appointment to the teaching positions. Further the period of active service spent on pursuing Research Degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experience for the purpose of direct recruitment/promotion. Regular faculty members' up to twenty per cent of the total faculty strength (excluding faculty on medical/maternity leave) shall be allowed by their respective institutions to take study leave for pursuing Ph.D. degree.
- 2.1.0 DIRECT RECRUITMENT For the Disciplines of Arts, Commerce, Humanities, Education, Law, Social Sciences, Sciences, Languages, Library Science, Physical Education, and Journalism & Mass Communication.

2.1.1 SENIOR PROFESSOR

Up to 10 percent of the existing sanctioned strength of Professors in the university may be appointed as Senior Professor in the universities, through direct recruitment.

i. An eminent scholar with good track record of high-quality research publications in Peerreviewed or UGC-listed journals, significant research contribution to the discipline, and engaged in research supervision.

- **ii.** A minimum of ten years of teaching/research experience as Professor or an equivalent grade in a University, College or an institute of national level.
- **iii.** The selection shall be based on academic achievements, favorable review from three eminent subject experts who are not less than the rank of Senior Professor or a Professor of at least ten years experience.
- iv. The selection shall be based on ten best publications in the Peer- reviewed or UGC-listed journals and award of Ph.D. degrees to at least two candidates under his/her supervision during the last 10 years and interaction with the Selection Committee.

Eligibility (A or B)

Α.

- i. An eminent scholar having a Ph.D. degree in the concerned/allied/relevant discipline, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer-reviewed or UGClisted journals and a total research score of 120 as per the criteria given in the University Regulation.
- ii. A minimum of ten years of teaching experience in university/college as Assistant Professor/Associate Professor/Professor, and/or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate.

OR

An outstanding professional, having a Ph.D. degree in the relevant/allied/applied disciplines, from any academic institutions (not included in A above)/industry, who has made significant contribution to the knowledge in the concerned/ allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

2.1.2 ASSOCIATE PROFESSOR

- i. A good academic record, with a Ph.D. Degree in the concerned/allied/relevant disciplines.
- **ii.** A Master's Degree with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).
- iii. A minimum of eight years of experience of teaching and/or research in an academic/ research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria given in University Regulation.

2.1.3 ASSISTANT PROFESSOR

Eligibility (A or B)

Α.

- (i) A Master's degree with 55% marks (or an equivalent grade in a point- scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. program prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- **d**) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- **e)** The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency. *The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.*
- **Note:** NET/SLET/SET shall also not be required for such Masters Programs in disciplines for which NET/ SLET/ SET is not conducted by the UG C, CSIR or similar test accredited by the UGC, like SLET/SET.

The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Note: The Academic score as specified in the University Regulation shall be considered for shortlisting of the candidates for interview only, and the selections shall be based only on the performance in the interview.

2.2.0 MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHING FACULTY IN UNIVERSITY- MANAGEMENT/BUSINESS ADMINISTRATION:

2.2.1 ASSISTANT PROFESSOR

i. Essential:

- 1. First Class Masters Degree in Business Management/Administration/in a relevant management related discipline or first class in two year full time PGDM declared equivalent by AIU/accredited by the AICTE/UGC.
- 2. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M. Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. program prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- **b)** The Ph.D. thesis has been evaluated by at least two external examiners;

- c) An open Ph.D. viva voce of the candidate has been conducted;
- **d**) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

OR

First Class graduate and professionally qualified Charted Accountant/Cost and Works Accountant/Company Secretary of the concerned statutory bodies.

ii. Desirable:

- **1.** Teaching, research, industrial and/or professional experience in a reputed organization;
- **2.** Papers published in conference proceedings and/or published in refereed journals.

2.2.2 ASSOCIATE PROFESSOR

i. Consistently good academic record with at least 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in Masters Degree in Business Management/Administration/in a relevant management related discipline or first class in two years full time PGDM declared equivalent by AIU/recognized by the AICTE/UGC.

OR

First Class graduate and professionally qualified Charted Accountant/Cost and works Accountant/Company Secretary of the concerned statutory body.

- **ii.** Ph.D. or Fellow of Indian Institute of Management or of an Institute recognized by AICTE and declared equivalent by the AIU.
- **iii.** A minimum of eight years experience of teaching/industry/research/professional at managerial level excluding the period spent for obtaining the research degree.

OR

iv. In the event the candidate is from industry and the profession, the following requirements shall constitute as essential requirements:

Consistently good academic record with at least 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in Masters Degree in Business Management/Administration/in a relevant management related discipline or first class in two years full time PGDM declared equivalent by AIU/recognized by AICTE/UGC.

OR

First Class graduate and professionally qualified Charted Accountant/Cost and Works Accountant/Company Secretary of the concerned statutory body.

A minimum of ten years experience of teaching industry/research/profession, out of which five years must be at the level of Assistant Professor or equivalent excluding the period spent for obtaining research degree. The candidate should have Professional work experience, which is significant and can be recognized at national/international level as equivalent to Ph.D. and ten years managerial experience in industry/profession of which at least five years should be at the level comparable to that of lecturer/assistant professor.

- **v.** Without prejudice to the above, the following conditions may be considered desirable:
 - a) Teaching, research industrial and/or professional experience in a reputed organization;
 - **b)** Published work, such as research papers, patents filed/obtained, books and/or technical reports; and
 - **c)** Experience of guiding the project work/dissertation of PG/Research Students or supervising R&D projects in industry.

2.2.3 PROFESSOR

i) Consistently good academic record with at least 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in Masters Degree in Business Management/Administration/in a relevant discipline or consistently good academic record with at least 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in two year full time PGDM declared equivalent by AIU/recognized by the AICTE/UGC.

OR

First Class graduate and professionally qualified Chartered Accountant/Cost and works Accountant/Company Secretary of the concerned statutory body.

- ii) Ph. D. or Fellow of Indian Institute of Management or of an Institute recognized by AICTE and declared equivalent by the AIU.
- **iii)** A minimum of ten years experience of teaching/industry/research/professional out of which five years must be at the level of Reader or equivalent excluding the period spent for obtaining the research degree.

- iv) In the event the candidate is from industry and the profession, the following shall constitute as essential:

1. Qualification same as those prescribed for the post of Professor from industry/profession stream with fifteen years experience of postgraduate teaching/research out of which five years must be at the level or Professor in the relevant discipline.

Without prejudice to the above, the following conditions may be considered desirable:

1. Administrative experience in senior level responsible position in the Industry/Professional Institution.

- **1.** A basic degree in pharmacy (B.Pharm.).
- 2 Registration as a pharmacist under the Pharmacy Act, 1948, as amended from time to time, including any succeeding enactments.
- **3.** A Ph.D. Degree with First Class at Bachelor's or Master's Degreein the appropriate branch of specialization in Pharmacy.
- **4.** Experience of eight years in teaching and/ or research at the level of Assistant Professor or equivalent grade; excluding period spent on obtaining the research degree.

2.3.3 ASSISTANT PROFESSOR

- **1.** A basic degree in pharmacy (B.Pharm.).
- **2** Registration as a pharmacist under the Pharmacy Act, 1948, as amended from time to time, including any succeeding enactments.
- **3.** First Class Masters Degree in Pharmacy in appropriate branch of specialization in Pharmacy.

2.7.4 PHYSICAL FITNESS TEST NORMS

- (a) Subject to the provisions of these Regulations, all candidates who are required to undertake the physical fitness test shall be required to produce a medical certificate certifying that he/she is medically fit before undertaking such tests.
- (b) On production of such certificate mentioned in sub-clause (a) above, the candidate would be required to undertake the physical fitness test in accordance with the following norms:

- **3.1.0** For selection procedures, the **University Regulation**, containing the Academic Performance Indicator (API) at the institutional level for the University, will be followed transparently in all the selection processes, including Career Advancement Scheme (CAS). The time to time changes amended by the UGC in the Academic Performance Indicator (API) will be adopted in the **University Regulation**.
- **3.2.0** In case this Ordinance is silent on any issues relating to Minimum qualifications and conditions for the post of Professors, Associate Professors and Assistant Professors in University for appointment of persons through Open Advertisement and promotion of working teachers through Career Advancement Scheme (CAS) the UGC regulations 2018 shall be referred.
- **3.3.0** Any amendments made by the UGC in respect of minimum qualifications and conditions for the post of Professors, Associate Professors and Assistant Professors in University for appointment of persons through Open Advertisement and promotion of working teachers through Career Advancement Scheme (CAS) will be immediately adopted in this Ordinance.

The revision is consequent upon UGC Regulations No. F. 1-2/ 2017 (EC/PS) dated 18 July, 2018 and will become effective from the date of its approval by the coordination committee and will supersede the repealed Ordinance.
