#### NEW ORDINANCE No. - 175

## FIVE YEAR INTEGRATED COURSE in ARTS, SCIENCE & SOCIAL SCIENCE

#### **OBJECTIVES:**

- > To attract young and bright students into the streams of Science, Arts and Social Science soon after they pass out from 10+2 stage.
- To instill scientific temper in the students that would develop a sense of excitement about Science, Arts and Social Science in them.
- > To prepare the students for a research career in Science, Arts and Social Science by providing them the best faculty, innovative teaching, modern laboratory and library facility and by exposing them to the frontline research areas in Science, Arts and Social Science.
- 1. The five year integrated course shall comprise of ten semesters, wherein, B.A./ B.Sc. Honours Course shall comprise of six semesters, i.e. Semester I to Semester VI and the remaining semesters, i.e. Semester VII to Semester X shall be known as M.A./M.Sc. course.
- 2.A candidate after passing 10+2 examination of Chhattisgarh Board of Secondary Education, Raipur or any other examination recognized by the University or Chhattisgarh Board of Secondary Education as equivalent thereto, shall be eligible for admission in I Semester of the Five Year Integrated Course. The procedure of admission shall be announced from time to time.
- 3.A candidate who has been admitted in first semester of the Five Year integrated course, and has attended a regular course of study for first semester shall be eligible for appearing in first semester examination.
- **4.**A student shall have option to quit the course after successful completion of semester I to VI examinations. In this case, he/she will be awarded a degree in B.Sc./B.A. (Honours) in respective subjects that he/she has offered major subject in B.Sc./B.A. semester V and VI.
- **5.**Honours Course: B.A./ B.Sc. Honours Course will be a six-semester degree course spread over three years. The structure of the course shall be as under: -

#### (A) Elective Papers:

- i) One major subject consisting of two compulsory papers in semester I to IV and six papers each in semester V & VI.
- ii) Combination of one major and two minor subjects as per the University prospectus published every year.
- iii) Major/ Honours subject will be decided on the merit of. the performance from I to IV semesters.

iv) In the subject where practicals are necessary there shall be practical course in addition to theory papers.

### (B) Compulsory Papers:

- > Foundation Course- (Hindi & English Language)
- Environmental Studies (Compulsory to pass at any time during semester I to VI of the course).

**6.**In order to pass in any of the I to VI semester examination, an examinee must obtain not less than 36% of total marks in each subject. In subjects where both Theory & Practical examinations are provided, an examinee must pass separately in both theory and practical examinations.

- 7. The results of each semester examination shall be determined separately.
- 8. The division of the candidate shall be determined on the basis of the aggregate of the total marks obtained in semesters I to VI examination.
- 9. A candidate after pursuing a regular course of study for semester VII shall be eligible for appearing in semester VII examination and to the next semesters.
- 10.A student failing to appear or securing less than 36% aggregate or obtaining less than 20% marks in any of the theory course of I, II & III semester examinations shall be allowed to pursue the courses for the next following semester. Such students shall have fail or fail in aggregate (with ATKT) or ATKT status in I, II, III or IV semesters and their scheme of examination shall be as follow:
  - A student failing to qualify the examinations of I & III (Odd semesters) and II & IV (Even semester) shall be permitted to appear in the ATKT/reexamination along with the following odd or even semester examination, respectively.
  - A student failing to qualify ATKT/reexamination of I semester shall be declared fail and his/her III semester examination shall be cancelled.
  - A student failing to qualify ATKT/reexamination of II semester shall be declared fail and his/her IV semester examination shall be cancelled.
  - A student failing to qualify ATKT/reexamination of III semester shall be declared fail and his/her IV semester examination shall be cancelled.
  - > A student who has failed in ATKT/reexamination shall reappear as ex-student.

11.M.A./ M.Sc. Course: A candidate after passing semester I to VI examinations, shall be admitted in semester VII of the major subject.

In the event of vacancy of seats in any subjects, students coming from the affiliated colleges/other Universities may also be admitted as regular student provided they qualify the entrance test specifically designed for them or the procedure laid down by the University.

12. After successful completion of the semester I to VI examinations, a candidate obtaining 60% or more marks in aggregate in all six semesters be placed in First Division Honors. The examinee who has secured 48% but less than 60% of marks in aggregate in all six semester examination shall be placed in Second Division Honors. The examinee securing 36% or more but less than 48% marks in aggregate shall be placed in Third Division, but they shall not be awarded Honors.

13.In order to pass in semester VII to X examinations a candidate must obtain not less than 36% of total marks in aggregate and 20% of marks in each paper of the subject. In the subjects where both theory and practical examinations are provided an examinee must pass separately in both theory and practical examinations.

14. The result of each semester examination shall be determined independently and candidate shall have to pass separately in each semester examination.

15. The division of the candidate shall be determined on the basis of his marks in semester VII to X examinations.

(d) First division : 60% o above marks.

(e) Second division: Less than 60% and more than 48%

(f) Third division: Less than 48% and more than 36%.

16. The scheme of examination for this course will be as proposed by respective Board of Studies and concerning faculty/faculties.

17.Ordinance No.6 (General Examinations for grace marks etc.) shall be applicable for this course also.

18. Ordinance No.170 shall govern the matters not covered in this Ordinance for M.A./M.Sc. course.
